F-1 DISCUSSION AND POSSIBLE ACTION TO APPROVE THE PURCHASE OF NEW PUMP FOR SOUTHSIDE SEWER PLANT LIFT STATION. KYLE MCCOY, WATER DIRECTOR, ADDRESSED COUNCIL ON SOUTHSIDE SEWER LIFT STATION PUMP QUIT WORKING. THE PUMP HAS BEEN FIXED SEVERAL TIMES SINCE IT WAS INSTALLED. THE COMPANY HAS CONTINUED TO FIX THE PUMPS BUT THE WARRANTY DOES NOT COVER TEMPORARY PUMPS, IT'S A COST TO THE CITY FOR RENTAL. THE WARRANTY WILL END SOON LEAVING THE CITY WITH ALL THE COST. DISCUSSED OPTIONS WITH REPAIRING EXISTING PUMP OR PURCHASING A NEW PUMP. HE IS REQUESTING FUNDS TO PURCHASE A NEW PUMP. BOB TARDIFF MADE A MOTION TO APPROVE THE PURCHASE OF NEW PUMP FOR SOUTHSIDE SEWER PLANT LIFT STATION AS AN EMERGENCY EXPENDITURE. SECONDED BY GINGER SIMS. ALL VOTED IN FAVOR.
